



How to apply for ACE Scholarships

Step 1: Logging In/Creating an Account



For Returning Applicants: If you already have a FACTS account simply “Sign In” to your account. All FACTS activity will be done through your existing account. If you are new to FACTS, you will click on “Create your Account”.

This ensures that your application is being shared with the school and ACE. The ACE Scholarships option will already be automatically selected when you come through the link from the ACE webpage. But please double check ensure that ACE Scholarships is selected. Then, simply click “Save & Continue” to move to the next section.
